Algaecide

Always use as directed. For control of algae in lakes, ponds, water gardens and water features.

Alguard Plus[®] contains dual biocidal activity for instantaneous and prolonged control of algae.

Active Ingredients: 10-30% Copper Ethanolamine Complex
<10% Benzalkonium Chloride

Metallic Copper Equivalent = 6.8%

Refer to chart below to determine litres of Alguard Plus[®] to apply per m³. Apply lower rates for light infestations. User higher rates on heavy blooms and where algae is clumped and accumulated. For best results apply by spraying evenly over the surface of the water.

MAXIMUM Dosage Rate by Volume

Volume	10m ³	100m ³	1000m ³
Dosage	20 - 90 mL	0.2 - 0.9 L	1.8 - 9.2 L

Note: Decaying algae can deplete dissolved oxygen which can lead to fish kill, if excessive. To minimise this hazard, do not treat more than 1/2 of the water body. Wait 14 days between treatments. Begin treatment along the shore and proceed outwards to allow fish to move into untreated areas.

Do not use in waters containing fish species that are highly sensitive to copper if the alkalinity is less than 50 ppm. Not to be used in ornamental ponds containing Koi.

Causes serious eye and skin irritation.

PREVENTION:
